THE ORGANIZATION LEASES PROPERTY FROM THE PRESIDENT AND TREASURER OF THE BOARD OF DIRECTORS, WILLIAM LEVI, FOR THE MAIN OFFICE HEADQUARTERS. THE LEASE PAYMENTS INCLUDE THE MORTGAGE PAYMENTS, UTILITIES, REPAIRS AND MAINTENANCE, AND ASSOCIATED COSTS.
